CALL TO ORDER

ENGINEERING REPORT -

Ed Fisher reviewed the Guiderail project map. They will be able to begin the guiderail study soon. He will arrange a meeting for us with Rush Township to go over the new Gaming Grant application.

He reviewed the current assessment permit process.

Daniels has applied for an assessment permit for a pavilion; due to it's location in the floodplain, the structure will have to be anchored.

<u>FIRE COMPANY REPORT</u> – John Witmer reported that they had one call for a tree down on the mountain. There was a general discussion about problems when calling in to the County for trees on wires.

<u>PLANNING COMMISSION REPORT</u> – Deb Everly had contacted the County to see if Powells Creek can be included in the proposed stream assessment program.

ROAD REPORT - Keith Crum reported that:

They will be moving on Saturday.

There was a discussion about adding fill along the edge of the recent paving project.

He will order some sealcoat for Middle Road.

He will be looking at placing fresh stone on the lower end of Hemlock Rd.

He will be looking at cost to do the remaining up-grades to the older guiderails; and will include the guiderail improvements recommended by the County for the bridge on West Cross Rd. Alan Loesch made a motion to sign the five year renewal of the State Winter Maintenance Agreement. Keith Crum seconded the motion. All in favor. Motion carried 3-0.

The Supervisors discussed the SEO issue and the available option and costs. Alan Loesch made a motion, seconded by Margaret Peterson to appoint Light-Heigel as SEO. All in favor. Motion carried 3-0.

Brenda Osman gave an update about tax collection issues. The County has gone to all computerized reports and tax bill scanners. However, they are not providing the equipment to the smaller municipalities. Richard Smeltz had asked if the house trailer on his property could be reclassified as a shed. The County will have to be contacted about the Mary Smeltz property, as the original agreement was made with Tri-County Planning.

The Supervisors discussed the current Fire Company by-laws issues. The by-laws need to be re-written. Margaret Peterson mad a motion to allocate \$1000 toward the cost of having the Township attorney help re-write these by-laws. Seconded by Keith Crum. All in favor. Motion carried 3-0. Margaret will contact Sam Mace and offer the Township's help.
