CALL TO ORDER

APPROVAL OF PREVIOUS MINUTES

- Alan Loesch made a motion to approve the minutes of the January 6, 2020 Reorganizational and Regular Meetings. Dennis Morgan seconded the motion. All in favor. Motion carried 3-0.

ROAD REPORT – Keith Crum reported that:

- We had some minor ice and snow
- He has filled the Hemlock Road potholes in the dirt area.
- Filled potholes on Middle and Back Roads.
- Installed new batteries in the GMC
- Filled in the shoulders along Hemlock Rd. Some spots needed gabion material.
- Took trees off of Hemlock Rd, Middle Rd and White Oak Rd. One of the downed trees on Hemlock Rd. bent a drain marker.
- We are waiting for information from Ed Fisher to see if the Dirt & Gravel Road program will cover paving shoulder and culverts on Hemlock RD.

- We still have two other grants pending for Hemlock Rd; the dirt section to get topped with DSA and the base work for the next section.

OLD BUSINESS

- No new updates on the West Cross Rd. bridge replacement.
- Still waiting for warm weather for painting work on the equipment shed.
- Alan sent out a letter to several residents requesting feedback about addressing in the Forks area.
- Alan Loesch made a motion, seconded by Dennis Morgan to register for domain name of Jefferson17032 with GoDaddy.com. All in favor. Motion carried 3-0.

NEW BUSINESS

- We have signed and paid for the Humane Society contract for stray dogs.
- Alan Loesch made a motion to approve the 2020-2021 COSTARS salt contract for 100 tons of salt. Dennis Morgan seconded the motion. All in favor. Motion carried 3-0.
- There have been some issues at the intersection of Middle and Carsonville Roads. We will check with Ed Fisher about what is needed to make it a “stop except right turn” coming down the hill.
- Margaret Peterson asked if the intersection of Back Rd and White Oak Rd should also become a two-way or three-way stop.
- Keith Crum is still interested purchasing in a large leaf blower. Leaf build-up has cars traveling down the center of the roads.
