CALL TO ORDER

ROAD REPORT Keith Crum Reported:

- He has been working on Hemlock Rd.
- Contacted Grossers for a quote on the two Back Rd. pipes
- He measured Hemlock and Middle Roads for the sealcoat bid, and Back Road for a paving bid.
- Alan Loesch would like to see the end of Middle Road repaired before the Carsonville Road County Bridge project., which might increase traffic on Middle Rd.
- Fox's Trailer was out to look at the GMC. The steering felt like it was jerking. A new filter did not improve it. Keith will look at the king pins.
- The Dirt and Gravel Road project is going well. Seven out of eight pipes are installed. We are waiting for one more headwall, and for New Enterprise to process our 2300 tons of 2A. Next, the Township will apply for another DCCD grant for the DSA topcoat.
- The bridge replacement project on West Cross Rd. is still progressing. The Township was just approved as a PennDOT business partner. The Township is responsible for \$46,000 in costs. Next, we will be signing the Reimbursement agreement.
- No update on the County Carsonville Rd. bridge deck replacement project.

### OLD BUSINESS

- We are still working on our stop sign Ordinance.
- The naming of private lanes to comply with 911 guidelines project is on hold until we can have more public input.

### NEW BUSINESS

- The Duncan stormwater project has been checked by Ed Fisher. He recommends the release of their project escrow.
- The Supervisors discussed participating in Wayne Township's clean-up day. After a general discussion, it was decided that the cost was too high for our level of participation.
- Jefferson Township is eligible for up to \$37,000 under the American Rescue Plan. However, the funds can only be spent on certain federally qualified projects. PSATS has been sending advisory updates.

ADJOURNMENT – Alan Loesch motioned to adjourn the meeting, seconded by Keith Crum. All were in favor and the meeting adjourned at 8:30.P.M.
