ROAD REPORT

- Keith Crum reported:
- He has been working on the gutter along Carsonville Rd at the bottom of the mountain. He has used both tractors on this project.
- Keith will be getting the old tractor ready for sale. He would like to put a \$20,000 reserve on it when it is posted on Municibid.

- The GMC is up at A&L for inspection and will need a new exhaust pipe. The rocker panels will be repaired.
- The hanging trees were taken down on Hemlock Rd.
- He has not heard any news about when the new Alamo mower or the new Ford 600 are coming.
- He will be mowing the road shoulders.

OLD BUSINESS

- Alan will have to walk back along Smokehole to verify the cabin locations.
- We have not heard back from Kendal about the lane name.
- Keith Crum asked that we double check with Ed Fisher to make sure that saw cuts are added to the Pre-Bid pipe project discussion.
- West Cross Rd. bridge replacement estimate from PennDOT no longer says Rummel Road, but the price is the same, listed at 1.6 million. Alan will contact PennDOT again to get some answers about the costs.
- There was a general discussion about what we want in a Driveway Ordinance. First would be the permitting of new driveways to prevent blind spots and drainage issues. A Nuisance Ordinance could be used to prevent obstruction or debris in the roadway.
- We have some issues with three-wheelers cutting into roadside banks and destroying gutters.
- We have some issues with logging trucks and are concerned that they could break up road edges.
- The Conservation District was up on the mountain looking at two logging locations.

NEW BUSINESS

- COG will be having a meeting on Sept 21st. The main topic will be the EMS issue.
