- The Road Survey was reviewed. Planning on paving from the Hotel to the Back Rd.; there are minor potholes on various roads; would like to sealcoat from West Cross Rd. to the Wayne Township line; need to patch on Back Rd. near Gobbler Lane: there are some dead trees; Keith has talked to Ed Fisher about the "stop except right turn" signage at Carsonville and Middle Rd. and we do not expect to do anything until after that area is paved. Ed Fisher will send a model ordinance.

- The Humane Society sent an updated agreement. There were fee changes. Alan Loesch made a motion to sign the Humane Society Agreement. Seconded by Dennis Morgan. All in favor. Motion carried 3-0.

ADJOURNMENT – Alan Loesch motioned to adjourn the meeting, seconded by Dennis Morgan. All were in favor and the meeting adjourned at 8:05 P.M.
