Alan Loesch made a motion to approve the Hahn Sub-division Plans as soon as Ed Fisher approves the Stormwater work. Margaret Peterson seconded the motion. All in favor. Motion carried 3-0.

ROAD REPORT - Keith Crum reported that:

- The paving work is complete and it was a very good job. Martins did some extra patching at no extra cost.
- The grading is finished on Carsonville Rd. and in the areas of Hemlock Rd. that need to be seal coated.
- The paved areas will be swept before the sealcoat bid work, which is scheduled for July 23rd.

- Future project; a double sealcoat for unpaved (gravel) area on Hemlock Rd. would cost approximately \$27,000.
- Need to contact Wayne Township about pipe at the end of Hemlock Rd. and discuss how to prevent future truck damage.
- The big truck will go in for inspection before August; it will need a new exhausts pipe.
- Some mowing has been done. We will be mowing the Rush Township side of the mountain when our roads are done.
